## Section 3. Composition/information on ingredients

## Section 4. First aid measures

- A. Eye contact** : Immediately flush eyes with plenty of water, occasionally lifting the upper and lower eyelids. Check for and remove any contact lenses. Continue to rinse for at least 10 minutes. Get medical attention if irritation occurs.
- B. Skin contact** : Wash with plenty of soap and water. Remove contaminated clothing and shoes. Wash contaminated clothing thoroughly with water before removing it, or wear gloves. If unconscious, place in recovery position and get medical attention immediately. Maintain an open airway. Loosen tight clothing such as a collar, tie, belt or waistband.

## Section 5. Firefighting measures

- B. Specific hazards arising from the chemical** : In a fire or if heated, a pressure increase will occur and the container may burst. - B. Appropriate engineering controls** : Good general ventilation should be sufficient to control worker exposure to airborne contaminants.
