### Section 3. Composition/information on ingredients

### Section 4. First aid measures

#### Description of necessary first aid measures

**Eye contact**: Get medical attention immediately. Call a poison center or physician. Immediately

flush eyes with plenty of water, occasionally lifting the upper and lower eyelids. Check for and remove any contact lenses. Continue to rinse for at least 10 minutes.

Chemical burns must be treated promptly by a physician.

### Section 6. Accidental release measures

#### **Environmental precautions**

#### Methods and material for containment and cleaning up

#### Small spill

#### Large spill

### Section 7. Handling and storage

#### Precautions for safe handling

#### **Protective measures**

Avoid exposure - obtain special instructions before use. Do not handle until all safety precautions have been read and understood. Do not get in eyes or on skin or clothing. Do not enter storage areas and confined spaces unless adequately ventilated. # Appropriate engineering controls
