Description of necessary first aid measures

Eye contact: Immediately flush eyes with plenty of water, occasionally lifting the upper and lower

Personal precautions, protective equipment and emergency procedures

For non-emergency personnel

Methods and material for containment and cleaning up

Small spill

Section 7. Handling and storage

Precautions for safe handling

Protective measures

Fut on appropriate personal protective equipment (see Section 8). Persons with a history of skin sensitization problems should not be employed in any process in which this product is used. Do not get in eyes or on skin or clothing. Do not breathe vapour or mist. Do not ingest. Avoid release to the environment. Use only with adequate ventilation. Disposal methods
