Prevention

Section 4. First aid measures

Inhalation

If not breathing, if breathing is irregular or if respiratory arrest occurs, provide artificial respiration or oxygen by trained personnel. Section 5. Firefighting measures

Extinguishing media

Suitable extinguishing media

Methods and material for containment and cleaning up

Small spill

Section 7. Handling and storage

Precautions for safe handling

Protective measures

: Put on appropriate personal protective equipment (see Section 8). Persons with a history of skin sensitization problems should not be employed in any process in which this product is used. Do not get in eyes or on skin or clothing. Do not ingest. Avoid breathing vapour or mist. Avoid release to the environment. Use only with adequate ventilation. Conditions for safe storage, : Store in accordance with local regulations. Store in a segregated and approved area.
