Description of necessary first aid measures

Methods and material for containment and cleaning up

Section 7. Handling and storage

Precautions for safe handling

Take precautionary measures against electrostatic discharges. Empty containers retain product residue and can be hazardous. Do not reuse container. Dry sanding, flame cutting and/or welding of the dry paint film will give rise to dust and/or hazardous fumes. Wet sanding/flattening should be used wherever possible. If exposure cannot be avoided by the provision of local exhaust ventilation, suitable respiratory protective equipment should be used.

Advice on general occupational hygiene

Conditions for safe storage, including any incompatibilities
