#### **Description of necessary first aid measures**

### Personal precautions, protective equipment and emergency procedures

For non-emergency personnel

: No action shall be taken involving any personal risk or without suitable training. Evacuate surrounding areas. Keep unnecessary and unprotected personnel from entering. ### Methods and material for containment and cleaning up

Small spill

# Section 7. Handling and storage

#### Precautions for safe handling

**Protective measures**

Do not get in eyes or on skin or clothing. Do not breathe vapour or mist. Do not ingest. Avoid release to the environment. Use only with adequate ventilation. Conditions for safe storage, : Store in accordance with local regulations. Store in a segregated and approved area. ### Appropriate engineering controls
