#### 5.2 Special hazards arising from the substance or mixture

### SECTION 6: Accidental release measures

#### 6.1 Personal precautions, protective equipment and emergency procedures

#### For non-emergency personnel

: No action shall be taken involving any personal risk or without suitable training. Evacuate surrounding areas. Keep unnecessary and unprotected personnel from entering. #### 8.2 Exposure controls

#### Appropriate engineering controls
