## **Precautionary statements**

## Description of necessary first aid measures

## Personal precautions, protective equipment and emergency procedures

## Methods and material for containment and cleaning up

# Section 7. Handling and storage

## Precautions for safe handling

Put on appropriate personal protective equipment (see Section 8). Persons with a history of skin sensitization problems should not be employed in any process in which this product is used. Do not get in eyes or on skin or clothing. Do not breathe vapour or mist. Do not ingest. Use only with adequate ventilation. Wear appropriate respirator when ventilation is inadequate.
