### Description of necessary first aid measures

Eye contact

#### Methods and material for containment and cleaning up

Small spill

# Section 7. Handling and storage

#### Protective measures

: Put on appropriate personal protective equipment (see Section 8). Persons with a history of skin sensitisation problems or asthma, allergies or chronic or recurrent respiratory disease should not be employed in any process in which this product is used.
