## Description of necessary first aid measures

## Personal precautions, protective equipment and emergency procedures

For non-emergency personnel

: No action shall be taken involving any personal risk or without suitable training. Evacuate surrounding areas. Keep unnecessary and unprotected personnel from entering. Do not touch or walk through spilt material. Shut off all ignition sources. No flares, smoking or flames in hazard area. Avoid breathing vapour or mist. Provide adequate ventilation. ### Methods and material for containment and cleaning up

Small spill

# Section 7. Handling and storage

### Precautions for safe handling

**Protective measures**

### Appropriate engineering controls
