Description of necessary first aid measures

Eye contact

Personal precautions, protective equipment and emergency procedures

For non-emergency personnel

Do not touch or walk through spilt material. Shut off all ignition sources. No flares, smoking or flames in hazard area. Avoid breathing vapour or mist. Provide adequate ventilation. Environmental precautions

Methods and material for containment and cleaning up

Small spill

Precautions for safe handling

Protective measures
