Section 4. First aid measures

Description of necessary first aid measures

Eye contact

Ingestion

Remove victim to fresh air and keep at rest in a position comfortable for breathing. If material has been swallowed and the exposed person is conscious, give small quantities of water to drink. Stop if the exposed person feels sick as vomiting may be dangerous. Do not induce vomiting unless directed to do so by medical personnel. Specific hazards arising from the chemical

Methods and material for containment and cleaning up

Small spill
