SECTION 4: First aid measures

4.1. Description of first aid measures

General

SECTION 5: Fire-fighting measures

5.1. Extinguishing media

Recommended extinguishing media; alcohol resistant foam, CO². powder, water spray.

SECTION 6: Accidental release measures

6.1. Personal precautions, protective equipment and emergency procedures

Remove sources of ignition, do not turn lights or unprotected electrical equipment on or off. In case of a major spill or spillage in a confined space evacuate the area and check that dust levels are below the Lower Explosive Limit before re-entering.

6.2. Environmental precautions

7.1. Precautions for safe handling

Handling

In Storage

Handle containers carefully to prevent damage and spillage.

8.2. Exposure controls

Provide adequate ventilation. Where reasonably practicable this should be achieved by the use of local exhaust ventilation and good general extraction. If these are not sufficient to maintain concentrations of particulates and any vapour below occupational exposure limits suitable respiratory protection must be worn.

Eye/face protection
