Description of necessary first aid measures

Section 4. First aid measures

Conditions for safe storage, including any incompatibilities : Store in accordance with local regulations. Store in original container protected from direct sunlight in a dry, cool and well-ventilated area, away from incompatible materials (see Section 10) and food and drink. Store locked up. Appropriate engineering controls : Use only with adequate ventilation.
